

Invitation for Bids (IFB)

Service Provider for Operation & Maintenance Of Tourism Coasters in Khyber Pakhtunkhwa

Managing Director Tourism Corporation Khyber Pakhtunkhwa, Peshawar invites sealed bids under National Competitive Bidding from reputed national and international Travel & Tour Operators, Transporters having at least 3 years of experience for the Services required for operation & maintenance of Tourism Coasters that meet the following eligibility criteria for the financial year 2019-20.

TERMS & CONDITION FOR ELIGIBILITY

1. Valid/renewed certificate of registration with legal/recognized professional bodies FBR (NTN & GST / KPRA Certificates), License of DTS (Directorate of Tourist Services), in the case of Company SECP Certificates, Firm/Company must be active on active tax payer list.
2. Bidding shall be conducted through **Single Stage–Two Envelopes** Bidding Procedure as per KPPRA Rules-2014. The bidders are bound to provide their complete information along with its postal as well as valid email address and phone number/s on the envelope.
3. Bidding documents, detailed description, can be obtained from the office of the undersigned during office hours against the non-refundable of Pak Rupees Two thousand (Rs.2000/-PKR).
4. The bids shall reach to the Office of the undersigned on or before **5th of Sep, 2019 at 11:00 am**. The bids shall be opened on the same day by the Procurement committee in the presence of Representatives of the bidders who chose to attend at **11:30 am** in the Conference Hall of Tourism Corporation Khyber Pakhtunkhwa Bids submitted after due date & time shall not be entertained.
5. The bid must be accompanied with Bid Security of amounting Rs. 500,000/- (Five Hundred Thousand) in the shape of Pay Order (PO)/Demand Draft (DD) or Call Deposit Receipt (CDR) in the name of the undersigned.
6. Affidavit on stamp paper to the effect that the bidder is not blacklisted by public organization, nor bankrupted by any scheduled commercial banks as well as non-involvement in any litigation.
7. Affidavit on stamp paper to the extent that all the information provided by the bidder is valid & updated.
8. Bids/Rates shall be quoted in Pak Rupees.
9. Pre-bid meeting shall be held on **29th of Aug, 2019 at 11:30 am** in the conference hall of the Tourism Corporation Khyber Pakhtunkhwa, under Rule 37(10) of the Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KPPRA) Procurement Rules 2014.

Bidders are required to offer most competitive highest rate exclusive of applicable taxes and mentioned all the applicable taxes separately for required services, as negotiations on quoted rates are not allowed under the rules. The bid must be valid up to 90 days from date of opening of the bid.
